#### An email from Carol Napper, Florida AAUW President

Good evening. A special conference call Wednesday involving AAUW and the White House was very encouraging. For one thing, it is great to see how closely Lisa Maatz is able to work with the White House staff! Martha Kanter, Under Secretary of Education, spoke for the first half of the call. She acknowledged the good things that AAUW has been doing and assured us that the Dept. of Education will continue to enforce Title IX, work on Sexual Harassment and make higher education affordable for all. They are working on a five year plan to keep interest rates low for student loans. They are very aware of the enormous amount of debt many college students have when they graduate. Ms. Kanter stated that no one should go broke to get an education. The Dept. of Education will be pressing states to avoid raising tuitions and fees and have a plan that will reward those institutions that make it possible for students to graduate with loans that can be paid back. They plan to put more pressure on schools by publishing lists of schools that have a good record when it comes to value, costs, (employment advantages) for students, graduation rates and other things that impact student choices for their education. They are planning a college Financial Score Card that easily shows college costs to help students compare colleges when they are looking at options.

You know about the "Race to the Top" that now goes through high schools. Ms. Kanter said they intend to continue that plan through college. Some of this, though, must go through Congress, and Ms. Kanter is hoping that the value of education is something the entire Congress will agree on. She says we need to keep college affordable and she is hoping for \$1 billion per year as an incentive to states to do what is asked in the above plans: to keep costs down and to graduate more students with less debt. She says this is not an "entitlement" program but is something the country needs to further education so that the US has an educated population. This is something we in Florida must keep an eye on. This is very much in the news right now as our legislators and governor try to make changes in our education systems at all levels.

The other subject covered in the White House conference call was Pay Equity. A new project was launched Tuesday by the Dept. of Labor. There will be a national task force on equal pay. They will be looking at ways to close the pay gap and ways to use technology to get the gap closed. I believe the technology will be used to show where the pay gaps exist and where changes can be made to have impact. You can get more information on this from their new website equalpay.challenge.gov.

I know this is a long email and maybe I should have put it in Microsoft word but I want everyone to know how much AAUW is doing in Washington and feel proud of what is being accomplished and what we can do in the future.

Please urge your members to attend the state convention. There is so much to learn and this is such a good opportunity to network with other branches. AND national Executive Director of AAUW, Linda Hallman will be our keynote speaker and with us for the whole convention. FloriVision will be out soon with all the details and the registration form. That information will also be on the state website.

# AAUW Luncheon Speaker: AAUW Luncheon Speaker: Chris Sprowls, Assistant State Attorney, Sixth Judicial Circuit

Chris Sprowls, shared his insights on a wide range of issues, opening with a topic of current interest: Redistricting. He reported that the Senate has released their version of the map, with the House version to be released next week. Once a joint resolution is achieved, and within a thirty-day period, the map will be reviewed by the State Supreme Court. State District Amendment No 5 requires contiguous districts, yet the proposed map(s) could raise some questions: Ex: Changes to the boundary in the Pasco – Hillsborough area that could upset the existing balance of coastal interests. Other points made by Assistant State Attorney Sprowls include:

- Privatizing Prisons: As a Prosecutor, he feels that most of the good evidence is
  received in jails, including information on gangs and in some cases, on planned or potential
  violence. If the prisons are run by private contractors, the question of access as well as who
  owns the information revealed there, could complicate the Prosecutor's job. Thus, he opposed the
  measure to achieve budget reductions by privatizing the Southern FL prisons.
- Bank Regulation: Will be the responsibility of the State Attorney General, complaints will not be heard at the circuit level. The State AG is now speaking for the Madoff victims here in Florida.
- Gangs: The Attorney General has a Task Force called the Gang Partnership Program consisting of Pinellas County, State and Federal authorities collaborating and information sharing. In Florida we currently have representation of most known gangs in our correctional facility: Ex: Sovereign Citizens, an extremist group who stand in opposition to US law enforcement. The various gangs also recruit young men of high school age with obvious impacts on the drop-out rate. 20 states currently have laws requiring their students to remain in school to age 18 years (as was recently proposed for the Federal level in the President's State of the Union Address). Is this an option for solving the gang and truancy problem? The street drug trade remains a big lure to young people in these hard economic times.

## HAPPY 35TH ANNIVERSARY, WEST PASCO AAUW!!!

A small group of stalwart women, under the leadership of Dorothy Shronk, decided to explore the possibilities of establishing a branch of AAUW in the New Port Richey area. The necessary steps were taken to organize a branch, monthly meetings were held and on May 7, 1977 an "Installation Luncheon" was held at Seven Springs Country Club to formalize the Charter process. The 54 Charter members included many who had been members of other branches.

# SUBJECT: WOMEN'S RIGHT TO VOTE.... SO EASY TO FORGET WHY WE HAVE THIS RIGHT.

THIS IS THE STORY OF OUR GRANDMOTHERS AND GREAT-GRANDMOTHERS WHO LIVED ONLY 90 YEARS AGO.

REMEMBER, IT WAS NOT UNTIL 1920 that women were granted the right to go to the polls and vote.



The women were innocent and defenseless, but they were jailed, nonetheless, for picketing the White House, carrying signs, asking for the vote. And by the end of the night, they were barely alive. Forty prison guards, wielding clubs, with their warden's blessing, went on a rampage against the 33 women, wrongly convicted of 'obstructing sidewalk traffic. They beat Lucy Burns, chained her hands to the cell bars above her head and left her hanging for the night, bleeding and gasping for air.

They hurled Dora Lewis into a dark cell, smashed her head against an iron bed and knocked her out cold. Her cellmate, Alice Cosu, thought Lewis was dead and suffered a heart attack.

Additional affidavits describe the guards grabbing, dragging, beating, choking, slamming, pinching, twisting and kicking the women.

Thus unfolded the 'NIGHT OF TERROR' ON NOV. 15, 1917, WHEN THE WARDEN AT THE OCCOQUAN WORKHOUSE IN VIRGINIA ORDERED HIS GUARDS TO TEACH A LESSON TO THE SUFFRAGISTS IMPRISONED THERE BECAUSE THEY DARED TO PICKET WOODROW WILSON'S WHITE HOUSE FOR THE RIGHT TO VOTE. For weeks, the women's only water came from an open pail. Their food--all of it colorless slop--was infested with worms.

When one of the leaders, Alice Paul, embarked on a hunger strike, they tied her to a chair, forced a tube down her throat and poured liquid into her until she vomited. She was tortured like this for weeks until word was smuggled out to the press.



The day after the police announce that future pickets would be given limit of 6 mos. in prison, Alice Paul led picket line with banner reading "The time has come to conquer or submit for there is but one choice - we have made it." She is followed by Mrs. Lawrence Lewis [Dora Lewis]. They received 6 mos. in prison.

SO, REFRESH MY MEMORY.

SOME WOMEN WON'T VOTE THIS YEAR BECAUSE - WHY, EXACTLY?
WE HAVE CARPOOL DUTIES?
WE HAVE TO GET TO WORK?
OUR VOTE DOESN'T MATTER?
IT'S RAINING?

Last week, I went to a sparsely attended screening of HBO's new movie '*Iron Jawed Angels*.' It is a graphic depiction of the battle these women waged so that I could pull the curtain at the polling booth and have my say. I am ashamed to say I needed the reminder.

All these years later, voter registration is still my passion. But the actual act of voting had become less personal for me, more rote. Frankly, voting often felt more like an obligation than a privilege. Sometimes it was inconvenient.

My friend Wendy, who is my age and studied women's history, saw the HBO movie, too. When she stopped by my desk to talk about it, she looked angry. She was--with herself.

"'One thought kept coming back to me as I watched that movie," she said. 'What would those women think of the way I use, or don't use, my right to vote? All of us take it for granted now, not just younger women, but those of us who did seek to learn.'

"The right to vote, "she said, "had become valuable to her all over again." HBO released the movie on video and DVD. I wish all history, social studies and government teachers would include the movie in their curriculum I want it shown on Bunco night, too, and anywhere else women gather. I realize this isn't our usual idea of socializing, but we are not voting in the numbers that we should be, and I think a little shock therapy is in order.

It is jarring to watch Woodrow Wilson and his cronies try to persuade a psychiatrist to declare Alice Paul insane so that she could be permanently institutionalized. And it is inspiring to watch the doctor refuse. Alice Paul was strong, he said, and brave. That didn't make her crazy. The doctor admonished the men: 'Courage in women is often mistaken for insanity.'

Please, if you are so inclined pass this on to all the women you know. We need to get out and vote and use this right that was fought so hard for by these very courageous women. Whether you vote democratic, republican or independent party, remember to vote.
